

# **ABRA Show Packet**

This show packet will have valuable information in it for you and your show staff to review prior to the show. The success of your horse show can be measured in different ways but being prepared is a valuable asset.

We strongly urge you make sure ALL persons involved in your ABRA approved show be totally familiar with the SHOW AND CONTEST RULES AND REGULATIONS in the current ABRA Rule Book in addition to information found in this packet. This packet contains guidelines that are not in the ABRA Rule Book.

#### **SHOW MANAGEMENT**

Always keep in mind that your staff will be a reflection AND promotion of our breed and should be friendly, cooperative, and hospitable to everyone at your show. Make sure your staff is knowledgeable of all ABRA rules and able to explain them to an exhibitor if questioned.

- Show Manager is officially in charge of making sure all pre-show work, show work, and post-show work is completed. Must be 18 years of age and a current member of ABRA. The Show Manager shall have the sole authority to enforce all rules referring to the Show or Contest. He/She may excuse any horse or exhibitor from the show or contest prior to or during the judging. At the end of the show, the Show Manager will receive from the Ring Steward a marked copy of the Show Bill signed by the Judges and the Ring Steward. This copy will be retained by the Show Management for at least three (3) years so they will be available upon request from ABRA. Not to interfere with the effectiveness of the show, the Show Manager should not serve as Show Secretary, Ring Steward or Announcer at the show. The Show Manager must be present on the show grounds the entire duration of the show. In the event of an emergency and the Show Manager is unable to fulfill his/her duties, an acting Show Manager can be assigned.
- Show Secretary is officially in charge of the Horse Show Office, accepting entries, processing and tabulating all classes, accounting for and sending complete results to the ABRA show office of ABRA classes only. The Show Secretary cannot be Show Manager, Ring Steward or Announcer at the show. The Show Secretary must be a current member of ABRA. The Show Secretary must ensure every exhibitor and horse is eligible to enter a class through the inspection of Horse Registration Certificates, Membership ID's and Class Eligibility Documents prior to taking an entry.

#### **ELIGIBILITY TO SHOW**

Any current ABRA member can show in ABRA approved classes. In order to show in an ABRA Open Class, an exhibitor MUST show their current ABRA Membership card or apply for an ABRA Individual Membership at the show. In order to show in ABRA Amateur classes, an exhibitor MUST show their current ABRA Amateur Card or apply for a current ABRA Amateur Membership at the show. In order to show in an ABRA

Youth class, an exhibitor MUST show their current ABRA Youth Card or apply for a current ABRA Youth Card at the show.

An ideal situation would be for any individual that has communicated with, or picking up judges for the event, should not show to those judges.

#### **TYPES OF MEMBERSHIPS**

The last recorded registered ABRA horse owner, and every exhibitor showing in an ABRA approved class MUST present a current ABRA membership card, a photocopy, or a digital copy at the time of entry. If they cannot, they MUST purchase one prior to entry being accepted. 3 Year and 5 year memberships are available through the ABRA office but not at a show.

#### • Individual Membership (Open)

Any individual may exhibit in the ABRA Open Classes, and must present his/her ABRA Individual membership card (photo copy or digital copy) in order to enter, or purchase the membership in the ABRA Show Office if he/she cannot produce the card. However, if the exhibitor is an Amateur or Youth, he/she may enter Open classes by presenting his/her Amateur or Youth Card. All ABRA Judges membership cards allow them to show in the ABRA Open Classes.

#### Amateur Membership

Every rider competing in an Amateur/ Amateur Select Class must possess a current Amateur card issued by ABRA, Inc. Show Management must inspect this card, photocopy of the card or digital picture of the card at the time of entry or purchase the membership in the ABRA Show Office if he/she cannot produce the card. Any horse exhibited by an Amateur in an ABRA approved Amateur Class or Event must be owned by the contestant or by the contestant's spouse, child, stepchild, father, mother, grandparent, grandchild, stepparent, sibling, half-sibling, step-sibling, spouse's parent, spouse's stepparent, sibling's spouse, half-sibling's spouse, step-sibling's spouse, niece, aunt, uncle, nephew legal ward or legal guardian as evidenced by records filed with ABRA. Unregistered weanlings are not eligible to compete in ABRA approved Amateur classes. Horses owned jointly or in a partnership with any person other than those listed above are not eligible to compete in ABRA approved Amateur classes. Horses owned by a ranch, far, etc. are not eligible to compete in ABRA approved Amateur classes. An Amateur must not exhibit horses owned by any third party in ANY class unless an Amateur Lease from ABRA, Inc. is provided.

#### • Youth Membership

Any contestant must not have passed his or her nineteenth (19) birthday as of January 1 of the current year. All youth must hold a current ABRA Youth Membership Card to exhibit in ABRA approved Youth classes. Show management must inspect this card, a photo copy, or digital copy of card, at any show at time of entry or purchase the membership in the ABRA Show Office if he/she cannot produce the card. Any horse exhibited by a youth in an ABRA approved Youth class must be owned by the contestant or by the contestant's parents, stepparents, sibling, half-sibling, step-sibling, niece, nephew, uncle, aunt, grandparents, step-grandparents, sibling's spouse, half-sibling's spouse, step-sibling's spouse, niece, aunt, uncle, nephew, or legal guardian as evidenced by records on file with ABRA, or owned by the institution in which the contestant is enrolled as a ward. Unregistered weanlings are not eligible to compete in Youth classes. Horses owned jointly or in partnership with any person

other than those listed above are ineligible to compete for ABRA points in ABRA approved Youth classes. Horses owned by a ranch, farm, etc., are ineligible to compete for ABRA points in ABRA approved Youth classes. No horse may be shown by more than one (1) exhibitor in any one (1) youth class. A Youth exhibitor may not show more than one (1) horse in any class other than in individual working events such as reining, barrel racing, jumping, etc. In individual working events, a Youth exhibitor may show two (2) horses, regardless of sex. Youth may not exhibit stallions in youth events. No married youth may exhibit in youth events. A youth may exhibit an ABRA registered horse in youth classes that is leased in the youth name. An official ABRA embossed Youth Exhibition Lease acknowledgment should be presented to Show Management with the copy of the horse's registration papers, a copy of the last recorded owner's current ABRA membership card, and the current ABRA youth membership card, whenever making entries in ABRA youth classes, and the owner of the horse must be listed on the show entry form as the last recorded owner on the registration papers.

#### MEMBERSHIPS SOLD AT SHOW

Exhibitors may purchase an ABRA membership at the show. Memberships sold at the show are referred to as ASAF (at show funds) and a copy of this form is in this Show Packet. These forms have a built in RUSH fee since they will be processed immediately after your show by the ABRA office and appropriate information sent to the Show Secretary to include in the Show Results before they are submitted. An ABRA Membership Renewal card sent out by the ABRA office CANNOT be accepted at the show, they must Re-new on the form provided in this packet. It is the responsibility of Show Management to provide the appropriate Membership form to the Exhibitor and to mail them to the ABRA office the day after the last day of your show. Show Management MUST make sure the date is marked on the Membership Form. Please make sure they are filled out legibly, if you can't read it, the office probably can't either. ASAF memberships need to be submitted to the ABRA office with a check made payable to ABRA. Do not include these membership fees with any other monies due ABRA.

#### RESPONSIBILITY DISCLAIMER

Included in this Show Approval Packet is a Disclaimer that MUST be posted at every ABRA Approved Show or Event. It is suggested you laminate the Disclaimer of Responsibility and the Show Manager or Show Secretary ensure its posting at your shows.

#### **SUBMITTING RESULTS**

All Results must be sent to the ABRA Office electronically within 14 days of the ending show date. It is very important the Show Results Check List in this packet be followed in order for ABRA points to be awarded. The Results check list at the end of this packet MUST be initialed, signed and submitted with results. If the signed check list does not accompany results, results are not considered complete.

#### JUDGE EVALUATION FORMS

Show Management MUST send in a Judge Evaluation Form to the ABRA office for each Judge. Your Show Results are not complete without these forms.

#### **GELDING STATEMENT**

A gelding still listed as a stallion according to ABRA records at the time show results are processed will be

disqualified if an ABRA Gelding Statement is not submitted by the owner within 14 days of the show. It is the responsibility of the owner to send the original Registration Certificate to the ABRA office. Show Management can inspect the horse, fill out the ABRA Gelding Statement and let the horse show. It is the responsibility of Show Management to make sure the ABRA Gelding Statement is sent to the ABRA office in Tulsa, OK the day after the last day of the show.

#### **SCORE SHEETS**

Show Management is responsible for collecting signed Score Sheets from the judges. Score Sheets must be signed and turned in to the show office by the judges for the following classes: Showmanship, Horsemanship, Equitation, Trail, Ranch Riding, Western Riding, Reining, Dun Factor, Buckskin Color, and Longe Line and all score sheets used in the Ranch Horse Division, Cattle Classes and Roping Classes. Show Management must use ABRA score sheets unless you are conducting a multi-breed show at which time AQHA or APHA score sheets may be used. Only Dun Factor and Buckskin Color Sheets need to be returned with your results. All other score sheets must be kept by Show Management for 3 years.

#### **BUCKSKIN BRED CLASSES**

Buckskin Bred Classes can be run concurrently with other classes but your Showbill MUST state they are run concurrently but judged separately. Buckskin Bred Horses cannot be included in a class count for Regular Registered Horse. Buckskin Bred Registration Numbers begin with B-XXXXX. The Regular Registry Registration Certificates issued prior to Jan 1, 2019 being with T or P. (T-XXXXX or P-XXXXX). Any horse registered Jan 1, 2019 or after will have an 'R' prior to the number which designates the horse is registered in the Regular Registry.

#### **MINIATURE/PONY CLASSES**

If you are offering Miniature/Pony classes, the Registration Certificate will begin with M-XXXXX for Miniatures and Y-XXXX for Pony. Entries in the Regular Registry Miniature/Pony classes are only those whose Registration Certificate show Buckskin, Dun, Red Dun, or Grulla. An animal with any other color on the Registration Certificate would have to enter a Buckskin Bred Miniature/Pony Class. The classes can be run concurrently but your Showbill MUST state they are judged separately.

#### **MULE CLASSES**

If you are offering Mule classes, the Registration Certificate will begin with D-XXXXX. Entries in the Regular Registry Mule classes are only those whose Registration Certificate show Buckskin, Dun, Red Dun, or Grulla. An animal with any other color on the Registration Certificate would have to enter a Buckskin Bred Mule Class. The Classes can be run concurrently but your Showbill MUST state they are judged separately.

#### **CONCURRENTLY RUN CLASSES**

If you are planning to run any ABRA classes concurrently with any other classes (AQHA, PtHA, All Breed, etc.) you MUST make sure the judges place all ABRA horses on separate ABRA judges cards. Example: If there are 25 horses in the class, the judges MUST place all 25 horses to be certain that all ABRA horses have been placed.



## **ABRA SHOW RESULTS SUBMISSION CHECKLIST**

	• <b>Grand and Reserve Halter Forms</b> – if using a program, you can enter these results and not have to complete the forms provided in the show packet. If it does not, you must complete a Grand and Reserve Halter Form for each judge.
	JUDGES CLASS CARDS – Must include ABRA class codes, class name and judge's signature. A copy of ALL judge's
	cards MUST accompany the above-mentioned items or your show results are not complete. DO NOT MAIL THE
	ORIGINAL JUDGES CARDS TO THE ABRA OFFICE. It is Show Managements responsibility to retain them for 3 years.
	MEMBERSHIP LISTING AND APPLICATIONS – Any new/renewed memberships sold at the show for Open, Youth,
	,
	or Amateur. Make sure the AFS ABRA Membership Application is the form used to purchase/renew members at
	the show. AFS Memberships fees have a built in late fee, that has to be collected or the membership is not valid.
	MONEY ORDER/CHECK FOR MEMBERSHP PURCHASED AT THE SHOW – This must be a separate check from the
	show assessment fee and <b>MUST</b> be mailed to the ABRA office in Tulsa the day after the last day of your show.
	<b>COMPLETED JUDGE EVALUATION FORM(S)</b> - There must be a form for each judge submitted by Show
	Management and sent to the ABRA office in Tulsa.
	<b>GELDING STATEMENT(S)</b> – Each set of registration papers must be inspected. If a stallion has been gelded and his
	original registration has not been stamped GELDING, the owner or exhibitor must fill out a gelding statement.
	Geldings still listed as stallions according to ABRA records when show results are processed will be disqualified
	from classes entered. Show Management must include a Gelding Statement with their show results. It is the
	owner's responsibility to send the original registration certificate to the ABRA office to get it changed to a
	gelding.
	ASSESSMENT FEE – An assessment fee of \$1 per horse per judge must be submitted to the ABRA office in Tulsa
	prior to the results being official.

# ABRA's Disclaimer of Responsibility for Safety

The sponsor of this ABRA-approved show is responsible for condition of show premises, including the arena and exercise areas; the conduct and competence of show activities and events; and all other aspects of this show.

ABRA does not assume responsibility for safety of participants at the shows or other events it sanctions.

Show management is responsible for participant safety. Show management applies for ABRA approval on a voluntary basis, agreeing to conduct the show according to ABRA rules, which are designed to promote fair competition.

Assumption of responsibility for safety by show management is required by ABRA as an express condition to grant the designation 'ABRA approved show.'

ABRA's objective is to require, by rule enforcement: a 'level playing field' of competition in order that performance of exhibitor and horse can be judged uniformly by competent judges; horses identified by registration certificate; and horses which perform or are exhibited free of illegal drugs or other prohibited substances which could affect their performance.

Safety is a concern of everyone, but ABRA does not assume responsibility for it. ABRA's purpose for sanctioning a show is to promote fair competition.

As an express condition of the privilege to participate at an ABRA-approved show or event, and by participating, each owner, exhibitor, trainer, and employees of any of these individuals, and all other participants, assume the risk of participation, and release and discharge ABRA, its officers, directors, representative, and employees, from any and all liability, whenever or however arising, as to personal injury or property damage occurring as a result of participation.



## **ABRA GELDING STATEMENT**

When a horse is gelded, the current recorded owner **MUST** notify the ABRA Office by sending the original registration certificate and notification of alteration of the horse.

A gelding still listed as a stallion according to ABRA records at the time show results are processed will be disqualified. ABRA must be notified, in writing, when a registered ABRA horse has been gelded.

The exhibitor/owner must submit the ORIGINAL REGISTRATION CERTIFICATE within 14 days of this notice, with the date the horse was gelded, so that it can be advanced and show results can be approved. (Include \$10 fee for advancing a horse over the age of 3.)
